IMPORTANT CIRCULAR

Students are informed that the School will re-open after summer vacation on **13th July 2017** for 2nd, 3rd, 4th and 5th year.

Admission to 2nd, 3rd, 4th and 5th year of the course, as the case may be, will be done on submission of prescribed application form along with details of fees remitted at the Academic Section of TNNLS.

Tuition Fees and other User Charges payable by students other than NRI category is Rs.1,91,000/- . NRI students should remit the tuition fees in US dollars as has been done earlier and user charges Rs.91,000/- in Indian rupees.

The admission to hostel and allotment of room will be done by the Resident Wardens / Faculty-in-Charge (Hostels) only on production of re-admission letter from the Academic Section.
