The above vacancies will be filled among the candidates who have already applied for “DIRECT ADMISSION” to TNNLS. Candidates who physically present at the TNNLS Campus on 29.07.2017 alone will be considered, for the counseling. The reporting time should be 10.00 A.M. (Saturday, 29.07.2017), and the candidates should register their presence at the admission desk by 12.00 P.M. on that day. The counseling will begin at the TNNLS campus at 02.00 p.m. on 29th July 2017 (Saturday).

FOR FILING UP THE VANCANCIES, THE FOLLOWING CRIETERIA WILL BE ADOPTED:

1. FIVE vacant seats in the All India General Category will be filled from among the ALL INDIA GENERAL CATEGORY candidates present at the Counseling in the order of merit [CLAT Score]. IN THE ABSENCE OF

SUFFICIENT NUMBER OF CANDIDATES AT THE COUNSELING UNDER THIS CATEGORY, THE SEATS WILL BE FILLED FROM STATE GENERAL CATEGORY CANDIDATES.

2. THREE State General Category vacancies will be filled from among the all Tamil Nadu category candidates present at the counseling in the order of merit [CLAT Score].

Other Instructions:

1. Candidates interested in participating in the counseling should report between 10.00 a.m. and 12.00 p.m. on 29.07.2017
2. The process of counseling will start at 02.00 p.m. on 29.07.2017
3. There is no guarantee for allotment of B.A. or B.Com. Stream preferred by the candidate in his / her application. **Allotment of course will be done subject to availability of seat and preference based on CLAT score.**
4. Selected candidates at the Counseling should be in a position to join immediately on 31st July 2017 as the classes for 1st year have already commenced on 13.07.2017, and should be ready to pay the prescribed fees on that day.
5. The following documents should be submitted while coming to take direct admission:
 1. Four Passport Size Photographs
 2. CLAT-2017 Rank List / CLAT Score Card.
 3. CLASS X Standard Examinations Mark-Statement
 4. CLASS XII Examinations Mark-Statement
 5. Transfer Certificate issued on completion of Class XII Course or last studied institution.
 6. Conduct Certificate issued on completion of Class XII Course or last studied institution.
 7. Community Certificate [for those selected on the basis of the reservations]
 8. Nativity Certificate [for those selected under Tamil Nadu Resident category]
 9. Medical Fitness Certificate [recently obtained from a Government Medical Officer].
